Treaty Negotiations: Progress to Date

Background

Maungaharuru-Tangitu Inc. (MTI) represents, manages and promotes the affairs and interests of the hapu of Ngai Tatara, Ngati Kurumokihi, Marangatuhetaua (Ngati Tu) and Ngai Te Ruruku ki Tangoio. Since 1992, MTI has managed the Treaty claims process on behalf of the hapu and is committed to resolving the claims for the benefit of the hapu: for those who have passed on, for those hapu members living today, and for the future generations to follow.

October 2009

Crown Recognises Mandate

On 20th October 2009, MTI's mandate to negotiate a settlement on behalf of the Hapu of Tangoio was recognised by the Crown.

December 2009

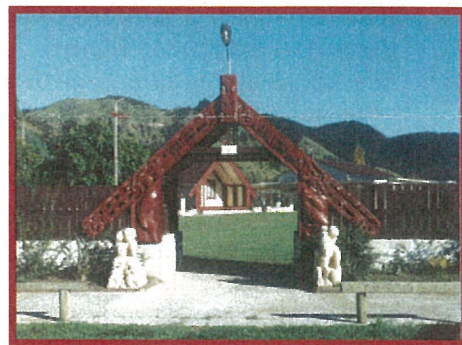
Operational Funds Secured

The determination and constant dedication of the MTI Komiti and our joint working group partner Ngāti Hineuru Iwi Inc, has enabled us to receive operational funding to produce the **Agreement in Principle** in 2010. However, recent delays with the Crown mean that the AIP phase is not likely to be complete until the first half of 2011.

March - May 2010

Hui-a-Hapu held

We held five Hui-a-Hapu in Napier, Whanganui, Wellington, Auckland and Whakatane during March, April

Treaty Negotiations (continued)

MTI NHII Large Natural Group

MTI is part of a Large Natural Group with Ngāti Hineuru Iwi Inc (NHII). The group enables MTI to share some of the costs of negotiation and management, while still retaining independence on behalf of the hapu of Tangoio. In line with our funding contract terms, the MTI Komiti and NHII Board have appointed a Joint Working Group to manage the negotiations process.

June 2010

Terms of Negotiation to be signed

Terms of Negotiation are with the Minister of Treaty Negotiations, and due to be signed this month.

Current Status

Overall, we have completed Step 1 of the Treaty Claims process, and are now making good progress in Steps 2 and 3. See table opposite.
